2023 in Review

President and General Manager

It is our pleasure to welcome everyone to Traverse Electric's 84th annual meeting on behalf of the board of directors and your co-op employees. This year's annual meeting will be held in-person at Wheaton High School on March 21st at 6:30pm. This year will be a business meeting only, where registered members, who stay for the business meeting, will receive a \$40 food voucher that can be used at many area participating businesses that are printed on the back of the voucher anytime until the end of 2024. Although we encourage everyone to use their \$40 vouchers at our area restaurants, vouchers may also be turned into Traverse Electric's office for a \$20 electric bill credit.

In 2023, TEC received high marks in several categories. Your Cooperative ended the year with \$13,196,324.43 in operating revenue and 130,279,409 in kWh sales. In addition, we ended the year with an operating margin of \$965,593.01 and total margins of \$2,057,392.91. We returned \$600,000 to estates and general retirement capital credits to those who received electricity in 2007 and 2008 due to the Cooperative's sound and stable financial condition. That adds up to more than \$11.3 million returned over the years quantifiable proof that you are an owner of a successful, effective organization.

The Cooperative's growth continued in 2023, with line crews installing and upgrading services for new homes, grain dryers, and tile pumps. In 2023, a total of 65 new services were installed. We continued to work on our maintenance programs, including pole testing, OCR maintenance, overhead line inspection, underground inspection, and right-of-way inspection. As part of our financial agreement with Rural Utility Services

(RUS), 2023 saw TEC work on our shortand long-term work plan. In partnership with STAR Energy, we were able to submit our 4-year and 15-year work plan that should be implemented starting in the fall of 2024. 2023, also saw TEC's safety incident rate return to zero. Safety is everyone's responsibility. Everyone needs to know that they have the ability to speak up if there is an issue. Safety is the number one priority at Traverse Electric. It doesn't matter what your job is, we all need to go home every night to our families.

Construction of our new building was mostly completed in late June, with staff moving over to the new building on July 7th. TEC hosted an open house in early October with great attendance! The new building has offered TEC more room to store our equipment inside and in our pole yard, all the employees are under one roof, and overall, a more efficient way to provide the services to you, our members. Looking forward to spring, TEC has contracted Traverse County Soil & Water to plant trees, wildflowers, and native prairie grasses on the west and north side of our building. As the trees & bushes grow, this will help block the snow and wind from our building.

While we are proud that planning and hard work has paid off, we still remind ourselves that dependable service and customer satisfaction are as – or maybe more critical – than bottom-line numbers. As we work our way into 2024, we will keep those thoughts in mind and continue to deliver more than just electricity to our members.

In closing, our sincere thanks to our members for your continued patronage this past year. We appreciate your business



83rd Annual Meeting Traverse Electric Cooperative, Inc.

Minutes, March 23, 2023

The eighty-third annual meeting of Traverse Electric Cooperative was held in the High School Auditorium at Wheaton, Minnesota on Thursday, March 23, 2023. Registration started at 6:00 p.m. The business meeting started at 6:30 p.m. with 96 registered members.

President Diekmann welcomed the members to their annual meeting and called the meeting to order.

The Pledge of Allegiance was recited.

President Diekmann asked the Secretary, Mark Pearson, to read the Notice of Mailing and Proof of Mailing. These were read. A register of attendance was presented. The chairman declared a quorum present and directed the register to become part of the official minutes.

President Diekmann called for the reading of the minutes of the last annual meeting and requested to dispense the reading of the minutes.

President Diekmann acknowledged the employees and directors in attendance.

President Diekmann introduced special guests from East River Electric: Bob Sahr and Chris Studer. #1529

General Manager, Jeremy Huhnstock, introduced himself and presented the 2022 Operating and Financial Reports. Topics reviewed included:

- Our March 31, 2022 and year end December 31, 2021 financials received a clean audit report by our independent auditing firm, CliftonLarsonAllen.
- 2022 operating revenue was \$12.1 million and kwh sales of 130 million.
- Reported that \$400,000 in revenue was deferred from 2022 to 2023.
- Reported that a class cost of service study was completed in 2022 as a tool to align costs.

- Reviewed new services connected and projects completed in 2022.
- Recapped the May 12th storm damage.

General Manager Huhnstock asked the membership if they had any questions on his reports. There were none. The reports were accepted.

President Diekmann gave the Presidents Report and encouraged members to read it as printed in the newsletter.

President Diekmann introduced board members and recognized former directors in attendance. The new facility project was also reviewed and this year's scholarship winners were announced.

President Diekmann opened the polls for the election directors. The candidates running for director from Districts 1 and 4 were running unopposed. Diekmann announced the following candidates who were nominated at the district meetings:

A motion was made and seconded from the floor to cast a unanimous ballot. Motion carried unanimously.

Huhnstock read a letter written by Wyatt Krueger who attended the 2022 Washington DC Youth Tour regarding his trip.

Bob Sahr, East River Electric's General Manager, spoke briefly.

The door prize drawings were held.

The chairman asked for any old business, and there being none, he proceeded to ask for any new business. There being none, it was moved and carried that the meeting be adjourned.
